- 1. Funeral with Visitation at Outside Facility\$ 6,550.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, setup for visitation and funeral at outside facility, two hearses, and graveside service.
- 2. Funeral with Visitation at Funeral Home\$ 6,050.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, two-hour visitation at funeral home, funeral service at funeral home or church, hearse, and graveside service.
- 3. Funeral with Visitation One Hour Prior\$ 5,800.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, extended service hour for visitation, funeral service at funeral home or outside facility, hearse, and graveside service.
- 4. Visitation at Funeral Home\$ 5,750.**
Includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, dressing, cosmetizing, casketing, use of facilities and staff for visitation, hearse, and graveside service.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director and Staff \$2,850.

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to the initial request for service; arrangement conference with family or responsible party; securing signed and certified copies of death certificate, recording vital statistics; preparation and filing of necessary authorizations and permits; staff assistance at all times, including consultation and coordination with those providing other portions of the funeral, e.g. cemetery, crematory, and others.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

Transfer of Remains to Funeral Home \$ 550.

(Additional transportation fees apply beyond 50 miles)

Embalming \$ 750.

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Direct Cremation From **\$ 3,550.** to **\$ 19,800.**

The charge for a direct cremation includes transfer of remains to funeral home, basic services of the funeral director and staff and cremation fee. This charge does not include the use of the facilities and staff for any visitation or ceremony, public or private.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials. The containers we offer are cardboard covered wood box or cloth covered cardboard.

Immediate Burial From **\$ 4,000.** to **\$ 20,250.**

Our charge for an immediate burial includes basic services of funeral director and staff, transfer of remains to funeral home, hearse, and equipment and staff for graveside service. It is our company policy that an immediate burial must take place within 48 hours of the time of death.

1. Immediate burial with minimum casket selected from funeral home **\$ 5,750.**
2. Immediate burial with casket provided by purchaser **\$ 4,000.**
3. Immediate burial with casket selected from funeral home (*see casket price list*) **\$ 4,000.**

Forwarding of Remains to Another Funeral Home **\$ 2,500.**

This charge includes transfer of remains to funeral home, basic services of funeral director and staff, embalming, minimum shipping container and transportation to local airport. This discounted service package does not include airline charges, any additional preparation of the body, visitation or ceremonies prior to forwarding of the body.

Receiving Remains from Another Funeral Home **\$ 2,800.**

This charge includes basic services of funeral director and staff, transfer of remains to funeral home, hearse, and equipment and staff for graveside service. This discounted service package does not include visitation or funeral rite or ceremonies prior to graveside interment.
